



Applicable to the public areas of the **Parc du Petit Prince**.

In order to guarantee the enjoyment and safety of each visitor, compliance by all with the conditions outlined in the present Internal regulations is essential.

1. GENERAL PROVISIONS

ARTICLE 1 – SCOPE OF APPLICATION

Entry into the premises, as a group or individually, implies the mandatory and unreserved acceptance of the present Internal Regulations. Should any of these rules be infringed, the park management is entitled to request that the offender leaves the premises immediately and without compensation. In addition, the Parc du Petit Prince denies any liability for any damage to property or bodily harm caused by a non-compliance with these Internal Regulations.

ARTICLE 2 – IMPLEMENTATION OF THE PRESENT INTERNAL REGULATIONS

These Internal Regulations are monitored by authorized staff members who give instructions to visitors. In the event of non-compliance, in particular if failures threaten the safety of property and individuals, the staff members are empowered to expel any offender(s) at their discretion if these instructions are not followed.

ARTICLE 3 – LEGAL ACTION

If and when required, the Parc du Petit Prince Management reserves the right to take legal action against any offender(s).

2. INSTRUCTIONS APPLICABLE TO VISITORS (ACCESS AND VISIT OF THE PARK)

ARTICLE 4 – CIRCULATION

Please walk only on public walkways when inside the Park premises. Visitors are not allowed to enter the following areas: areas protected by a fence, barrier, chain, door or any other protection indicating that the area is not accessible to the public or bearing a "prohibited" or "private" sign, service areas, even if they have been left open temporarily, attractions, show areas and their perimeter closed to the public, emergency exits and fire brigade entrances which must remain accessible at all times. The Highway Code applies to all roads on the premises. Visitors are requested to comply with its rules, and with the speed limits within the boundaries of the Parc du Petit Prince.

ARTICLE 5 – CHILDREN

Children under 16 must be accompanied by a parent or a responsible adult to access the park and the attractions. The Parc du Petit Prince Management strongly recommends that parents and accompanying adults do not leave children under 12 unattended in the park premises. Otherwise, the responsibility of the Parc du Petit Prince could not be engaged. During their family or group visit, children under 16 years old are entirely under the responsibility of their parents or accompanying adults and should be under continuous surveillance.

ARTICLE 6 – SEARCHES

When warranted or at the request of the Public Authorities, the Parc du Petit Prince Management may be required to search the bags and personal effects of visitors for security reasons. These searches will be conducted at the entrance of the site, or in the park premises past the ticket booths and visitors are requested to submit to them in their own interest and that of others. No weapons of any nature, even inoffensive imitations, or any dangerous and/or illegal objects or products, including alcoholic beverages, are allowed inside the Park. Staff conducting the searches is authorized to confiscate or store the objects concerned.

ARTICLE 7 – DRESS CODE AND BEHAVIOUR

Appropriate clothing should be worn on the site. No bare feet, bare chest and generally nothing that could be interpreted as immodest or immoral will be tolerated. Furthermore, the disturbance of other visitors by hostile, excessive or ostentatious behavior is not allowed. The Parc du Petit Prince staff shall enforce this rule, possibly at the request of visitors. To this effect, visitors must: have a benevolent attitude to others, follow the instructions and indications given by the staff, queue in turn, respect the scenery, trees, bushes, lawns and equipment of the site, as well as the property of other visitors, not use radios, horn, megaphone or other audio equipment and instruments, not use bikes, skateboards, scooters, rollers and in general any travel vehicles, motorized or not, which are not allowed inside the park except upon presentation of a medical certificate, throw paper, waste or cigarettes in the appropriate bins and ashtrays, not use cell phones in the auditoriums. To refrain from engaging in commercial transactions of any nature including the resale of entrance tickets of the Park, to circulate in the auditoriums during projections, to take pictures with a flash during projections.

ARTICLE 8 – ANIMALS

Dogs, cats and other pets are not allowed in the Park. Guide dogs and assistance dogs for people with disabilities are accepted on presentation of a valid proof and can therefore accompany their masters throughout their day. However, for security reasons some attractions are not accessible to guide dogs. They must be leashed and remain under the supervision of the owner.

ARTICLE 9 – PICNIC

The picnic is allowed only on dedicated areas in the Park. We invite every visitor to leave this area clean and tidy.

ARTICLE 10- IMAGE RIGHTS OF THE SITE

Only photographers and amateur filmmakers are authorized to shoot the site, for a strictly limited family use. Professionals are asked to contact the administration of the Parc du Petit Prince.

ARTICLE 11 – PROHIBITION OF ANY UNAUTHORIZED COMMERCIAL ACTIVITY

The sale of all goods and / or the provision of all services, and distribution of business documents by visitors is strictly prohibited within the Park. It is also strictly forbidden to proceed to the resale of entrance tickets of the Park.

3. ATTRACTIONS ET AUDITORIUMS

ARTICLE 12 – AVERTISSEMENTS

Visitors are asked to consider the warning presented at the entrance of each attraction symbolized by captioned pictograms. Visitors must check whether or not the attractions are adapted to them, particularly with regard to their age, physical and mental condition. For safety reasons, the accessibility and the participation in some attractions require a good physical condition, a good health, no suffering from hypertension or heart problems or any other health problems or disability likely to be aggravated by the use of such attractions. Each visitor must check his health condition before coming into the Park and must have read the warnings, access conditions and security rules by reviewing the information presented at the entrance of each attraction and auditorium. Restrictions based on age, health condition and / or safety does not constitute discriminatory measures. In case of non-compliance with these regulations, the Management declines any responsibility in case of physical or direct or indirect material damages.

4. SAFETY INSTRUCTIONS

ARTICLE 13 – SPECIFIC CONDITIONS TO AIRCRAFT FLIGHT

The Park contains several aircrafts with specific conditions of use. Flights are regulated by the Treaty of the Warsaw Convention and visitors are therefore committed to fully adhere to it when boarding the aircrafts. Visitors undertake to permanently keep their tickets which also serve as a boarding pass.

ARTICLE 14 – PARKING

Parking is under the responsibility of the vehicle owner. The Parc du Petit Prince shall not be liable for damage sustained by vehicles due to events beyond its control. The Parc du Petit Prince strongly recommends that visitors make sure their vehicles are locked. Do not leave any animals or valuables inside vehicles.

ARTICLE 15 – PERSONNAL EFFECTS

Visitors are responsible for their personal effects, in particular clothes, bags, glasses, cameras... No claims against the Parc du Petit Prince will be accepted in the event of loss, theft or damage.

ARTICLE 16 – BEHAVIOUR OF THE VISITORS

Theft, public disturbances, verbal and physical abuse, insults, fraud, scams, state of inebriation, obscenity, malice, violations of the safety rules and the internal rules, manifestations of racism, may lead the Management to intervene and take the necessary measures or ask the visitor to leave the Park with no compensation.

ARTICLE 17 – EVACUATION OF THE PARK

The Management reserves the right to limit or deny access to the Park or to evacuate the Park if the attendance rate is too high for safety reasons or in the case of force majeure.

ARTICLE 18 – VIDEO SURVEILLANCE

In conformity with the Decree No. 96-926 of October 17th 1996 on video surveillance, the Management of the Parc du Petit Prince informs visitors that they are being filmed by a video surveillance system.

5. MISCELLANEOUS

ARTICLE 19 – OPENING HOURS

The opening and closing hours of the Parc du Petit Prince are provided for information only. Depending on the circumstances, the Management of the little Prince Park reserves the right to modify the opening and closing hours to preserve the safety of visitors and / or the employees of the Parc du Petit Prince.

ARTICLE 20 – UNAVAILABILITY

The unavailability of one or more services (attractions, shows and / or entertainment), for any reason, is not entitled to any compensation. It is the same in the case of unavailability of all or part of certain areas due to weather conditions.
